In consideration of being allowed to participate in the 2nd Annual Kaua'i Youth Football Shoreline Fishing Tournament, I acknowledge and agree to the following:

I also understand while complying with particular tournament rules, correct use of equipment, and personal discipline may reduce this risk.

2. I have been advised by tournament officials of the contents of this document through reading it, and have had the opportunity to seek legal counsel with respect to the legal effect of this document prior to signing it.

3. I knowingly and freely assume all risks referred to above, and all other risks of tournament participation, both known and unknown, even, without limitation, if arising from the negligence of the Releasees (as defined below) or others, and assume full responsibility for risks arising from my participation in the tournament.

4. I willing agree to comply with the terms and conditions for participation in this tournament and should I observe any unusual hazard(s) in my presence or during participation which could potentially cause injury or damage to any person, I will remove myself from participation and bring such hazard(s), to the attention of the nearest tournament official immediately.

5. 1. Registration commitments and payments shall be received **no later than 5:00 p.m. on March 21, 2019.**
2. Tournament Days and Times are from Friday, March 22, 2019 after 12:00 p.m. to March 24, 2019 at 9:00 a.m.
3. All Shorecasters are to start no earlier than 12:00 p.m. on Friday, March 22, 2019.
4. Weigh-In will be open from 10:00 a.m. to 12:00 p.m. on March 24, 2019.
5. ALL FISH NEEDS TO BE WEIGHED IN AT NAWILIWILI BEACH PARK NO LATER THAN 12:00 P.M. OR YOU WILL BE DISQUALIFIED.
6. Mutilated fish will not be eligible.
7. FISH MUST BE CAUGHT ON HOOK AND LINE.
8. Ulua Point may be accessed only from river side and/or hiked in.
9. SHORECASTING ONLY (NO DRONE OR KAYAKING, ETC. TO SET LINE OUT).
10. NO SHIBI, AKU OR KAWAKAWA ***THIS IS A SHORELINE TOURNAMENT***.
11. There are No Fishing Boundaries.
12. Report your catch as soon as possible by calling in and sending a photo to Brad at (808) 652-9962 when you have a big catch, as in the case of a tie, we will go with length.
13. There will be Spotters around the island.
14. Parent or legal guardian must accompany child at all times.
