1. Registration commitments and payments shall be received **no later than 5:00 p.m. on June 28, 2018.**
2. Tournament Days and Times are from Friday, June 29, 2018 after 12:00 p.m. to July 1, 2018 at 9:00 a.m.
3. All Shorecasters are to start no earlier than 12:00 p.m. on Friday, June 29, 2018.
4. Weigh-In will be open from 10:00 a.m. to 12:00 p.m. on July 1, 2018.
5. **ALL FISH NEEDS TO BE WEIGHED IN AT NAWILIWILI BEACH PARK NO LATER THAN 12:00 P.M. OR YOU WILL BE DISQUALIFIED.**
6. Mutilated fish will not be eligible.
7. **FISH MUST BE CAUGHT ON HOOK AND LINE.**
8. Ulua Point may be accessed only from river side and/or hiked in.
9. **SHORECASTING ONLY (NO DRONE OR KAYAKING, ETC. TO SET LINE OUT).**
10. **NO SHIBI, AKU OR KAWAKAWA \*\*\*THIS IS A SHORELINE TOURNAMENT\*\*\*.**
11. There are No Fishing Boundaries.
12. Report your catch as soon as possible by calling in and sending a photo to Brad at (808) 652-9962 when you have a big catch, as in the case of a tie, we will go with length.
13. There will be Spotters around the island.
14. Parent or legal guardian must accompany child at all times.

## **WAIVER OF LIABILITY AND RELEASE FORM**

In consideration of being allowed to participate in the 1<sup>st</sup> Annual Kaua'i Youth Football Shoreline Fishing Tournament, I acknowledge and agree to the following:

I also understand while complying with particular tournament rules, correct use of equipment, and personal discipline may reduce this risk.

2. I have been advised by tournament officials of the contents of this document through reading it, and have had the opportunity to seek legal counsel with respect to the legal effect of this document prior to signing it.

3. I knowingly and freely assume all risks referred to above, and all other risks of tournament participation, both known and unknown, even, without limitation, if arising from the negligence of the Releasees (as defined below) or others, and assume full responsibility for risks arising from my participation in the tournament.

4. I willing agree to comply with the terms and conditions for participation in this tournament and should I observe any unusual hazard(s) in my presence or during participation which could potentially cause injury or damage to any person, I will remove myself from participation and bring such hazard(s), to the attention of the nearest tournament official immediately.

5. I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, hereby release, indemnify, and hold harmless Kaua'i Youth Football, the Officers, Officials, Directors, Staff, Other Participants, and Sponsoring Agencies, Sponsors, Advertisers, and, if applicable, Owners and Lessors of premises and property used to conduct the event ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, which I suffer or which I am found to have caused in whole or in part by my negligence or intentional misconduct, whether arising from the negligence of the Releasees, or otherwise, to the fullest extent permitted by law.
